# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
<b>ELIGIBILITY</b>	<p>Open to citizens of all countries that have diplomatic relation with Malaysia (<b>except Israel and North Korea</b>)</p> <p><b>Applicant must make a declaration of their country of origin and citizenship(s) before making an application</b></p>
<b>MINIMUM STAY</b>	<p><b>Minimum 30 cumulative days</b> per year in Sarawak. <b>(for main applicant only)</b></p>
<b>FIXED DEPOSIT</b>	<p>Total amount of FD according to the category:</p> <p><b>RM500,000</b> (main applicant)</p> <p><i>FD placement mandatory in any local bank in Sarawak</i></p> <p><i>Allowed to withdrawal 50% of FD placement after one year in the program for the purpose buying a residential house, purchase of a car, medical and children education in Sarawak.</i></p>

# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
OFFSHORE INCOME	<p><b>RM10,000 (Individual) per month, RM15,000 (Dependent) per month</b></p> <p>Certified copy of <b>Pension Letter</b> and <b>latest 3 months government approved pension funds</b></p> <p>OR</p> <p>Certified copy of <b>Employment Confirmation</b> and <b>latest 3 months pay slip and bank statement</b> as a proof of <b>monthly offshore income funds.</b></p> <p>OR</p> <p><b>RM100,000 (Individual), RM200,000 (Dependent)</b></p> <p>Certified copy of bank statements as proof of <b>savings fund</b> for the <b>last 3 months financial statement.</b></p>
AGE ELIGIBILITY	<p><b>30 years old and above</b></p>

# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
<b>PASS DURATION</b>	<p><b>10(5+5) years and renewable upon expiry</b></p> <p>For renewal, the existing participants are still adhered to existing requirements.</p> <p>After 10 years, applicant must apply as a <b>NEW APPLICATION</b></p>

# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
LIQUID ASSET	<p>Property purchase is optional for all applicants. The approved participant is allowed to purchase a <b>residential house</b> in Sarawak with value at least <b>RM600,000 (Kuching Division)</b> and <b>RM500,000 (other Divisions)</b> subject to <b>Land Code (Amendment)(No.2) Order 1998 &amp; Land (Market Value of Property for Foreign Acquisition) Direction 1998.</b></p> <p>(The participant can sell their <b>residential house after 5 years</b>)</p>
FEE	<p><b>One off RM5,000 processing fee to MTCP</b></p> <p><b>(Note: The processing fee is for first 5 years pass)</b></p>

# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
<b>INVOLVEMENT IN EMPLOYMENT / INVESTMENT</b>	<p><b>All S-MM2H participants are not eligible to work.</b></p> <ul style="list-style-type: none"><li>• S-MM2H participants are <b>not eligible</b> to work <b>full time</b></li><li>• S-MM2H participants are only <b>eligible</b> to work <b>part time</b> in professional jobs in sectors approved by the ILMU thru MTCP</li><li>• Total working hours must not exceed 20 working hours per week</li><li>• S-MM2H participants are <b>allowed</b> to be “<b>Minority partner</b>” in Joint-venture (JV) business with local partner in sectors approved by ILMU. S-MM2H participants must own minimum 49% of the total paid-up capital of RM250,000 (minimum).</li><li>• All applications to work under S-MM2H programme must be made to the State Authority.</li></ul> <p><b><u>Professional sector:</u></b> <b>Education, Banking/Securities, Manufacturing and Medical.</b></p>

# ENHANCEMENT OF S-MM2H REQUIREMENTS

REGULATIONS	CONTENTS
<b>PASS RENEWAL, CHANGE OF PRINCIPAL APPLICANT AND NATIONALITY</b>	PDRM Security Screening
<b>LETTER OF GOOD CONDUCT</b>	Principal applicant and all dependent(s)
<b>RESPONSIBLE AGENCIES</b>	Ministry of Tourism, Creative Industry and Performing Arts Sarawak (MTCP)
<b>ALLOWED TO BRING MAID</b>	<b>YES</b> (All applicant are allowed to bring maid subject to applicant compliance of current requirement of entry for foreign maid by Immigration Department)

# ENHANCEMENT OF S-MM2H REQUIREMENTS

<b>REGULATIONS</b>	<b>CONTENTS</b>
<b>ALLOWED DEPENDENT CATEGORIES</b>	YES
<b>EDUCATION AND HEALTHCARE BENEFIT</b>	Applicant must be covered by medical insurance for the duration of their S-MM2H pass.
<b>TAX EXEMPTIONS ON FUND BROUGHT IN</b>	YES



# ENHANCEMENT OF S-MM2H REQUIREMENTS

<b>HEALTH EXAMINATION</b>	REQUIRED
<b>TRANSFER OF MM2H PASS UPON PRINCIPALS'S DEATH</b>	NO
<b>PERMANENT RESIDENCE STATUS</b>	NONE
